(Road running / Cross-Country membership does not include the privilege to participate in sanctioned track and field competitions. You must upgrade to track and field membership status in order to compete.)

TRACK AND FIELD BASIC MEMBERSHIP \$40.00; FAMILY MEMBERSHIP \$100.00
(Includes road running and cross-country membership.)

ONE DAY REGISTRATION \$5.00 (Applies to all sanctioned events. Affects non-members only.)

ONE DAY REGISTRATION FOR PRIMARY AND SECONDARY SCHOOL ATHLETES DURING THE SCHOOL YEAR IS \$1.00. (Applies only for NLAA sanctioned events which are organized for schools exclusively and school grades are used for determining the age categories. Affects non-members only.) During the school year schools may join as associate clubs for \$20.00. All school athletes will then be considered NLAA members for the duration of the school year, and may compete under their school name in NLAA sanctioned events. In other words, each school athlete obtains a membership once their school registers as an associate club. Continuing to compete in summer competitions would require upgrading to a full membership.
